PERSONAL DATA CLARIFICATION/ENLIGHTENMENT TEXT

This Personal Data Clarification/Enlightenment Text is prepared with the intent of acknowledging you about collecting/compiling, processing, transferring your personal data pursuant to Law Number 6698 About Protecting Personal Data ("**Law**") including your rights under the said Law.

In our capacity of Data Supervisor, we are processing your personal data in accordance with the Law as well as relevant legislations in practice, within framework of the scope described hereinbelow.

Personal Data We Are Processing

With the purpose of realizing our objectives towards processing personal data as specified under this Clarification/Enlightenment Text, we are entitled to process the following personal data:

- Your Name, Surname, Date of Birth, Place of Birth, Republic of Turkey Identity Number, as well as such other identity data and particulars contained in the civil identity card/driver's license/passport;
- Your communication data including E-mail address, telephone number, mobile phone number;
- Your location particulars including home and business address data;
- Your Photograph;
- Your customer transactions data including customer orders, request and complaint particulars;
- Your transaction security data including IP address as well as Web Site incoming-outgoing data;
- Your financial data including your bank card, credit card IBAN particulars, digital account book data (public key);
- Your usage habits, data regarding past product/service purchases and marketing data including cookies;
- Your transaction security data and particulars including IP address as well as Web Site incoming-outgoing data;
- Your financial data and particulars including Bank account and IBAN data;
- Results of inquiries filed before any public institutions, risky/suspicious transaction notifications.

Our Objectives In Processing Personal Data

We are processing your personal data as limited to the following objectives and purposes:

- Conducting AHICOIN(AHI) sales processes,
- Conducting AHICOIN(AHI) after sales support services,
- Conducting processes for (re)purchasing products/services (AHI),
- Conducting product/service (AHI) manufacturing and operation processes,
- Conducting customer relations management processes,
- Conducting activities regarding customer satisfaction,
- Conducting company/product/service loyalty processes,
- Conducting agreement processes,
- Conducting/auditing business activities,
- Conducting communication activities,
- Conducting finance and accounting operations,
- Conducting operations in accordance with the legislations,
- Conducting marketing analysis activities,
- Conducting advertising campaigns/promotion processes,
- Conducting product/service marketing processes,
- Following-up claims/complaints,
- Following-up and conducting legal matters,
- Conducting supervisory/ethical activities,
- Providing information to authorized persons/entities and institutions,
- Conducting data security processes,
- Conducting access procedures,
- Conducting risk management processes.

Our Method For Collecting/Compiling Personal Data

We are collecting your personal data through the following channels, automatic as well as otherwise, as listed hereinbelow:

- E-mail, SMS, business cards,
- Telephone,
- Cookies and such other similar follow-up technologies,
- Our Web Site,
- Mail, cargo or courier services,
- Other physical and electronic media.

Our Legal Causes Regarding Processing

We are processing your personal data within framework of such terms and conditions for processing listed and specified under Articles 5 and 6 of the Law.

- As set forth under Article 5/2(a) of the Law, being expressly prescribed under the laws;

- Provided being directly related to the generation or performance of an agreement set forth and specified under Article 5/2(c) of the Law, processing of any personal data belonging to the parties of such agreement are required to be processed,
- Being necessary for fulfillment of our Company's legal obligation specified under Article 5/2(ç) of the Law,
- Personal data specified under Article 5/2(d) of the Law, already having been made public of the person concerned,
- Data processing being mandatory for establishment, usage or protection of any right specified under Article 5/2(e) of the Law,
- Provided basic rights and liberties of the relevant persons as listed and specified under Article 5/2(f) of the Law are not prejudiced, processing of data by our Company being compulsory for legitimate interests.

Transfer Of Your Personal Data

We are allowed and entitled to transfer and convey your personal data within framework of such processing conditions specified under Articles 8 and 9 of the Law and being limited to the purposes and objectives indicated hereinbefore, to our employees, business partners, shareholders, suppliers both locally as well as abroad, company agents and attorneys and any legally authorized public/private entities and organizations.

Your personal data are of such capacity to be accepted by AHICOIN under the title "donation" and on grounds of any and all kinds of services intermediated, could possibly be transferred to any and all kinds of private/public entities and organizations like associations, municipalities, foundations.

Your Rights Regarding Your Personal Data

Pursuant to Article 11 of the Law, you are entitled to the following rights in relation with your personal data:

- Knowing whether or not your personal data are processed,
- If your personal data are processed, claiming information regarding such processing,
- Learning the reason for processing of personal data and whether or not these are used in accordance with the relevant purpose,
- Knowing about any third parties whom your personal data are transferred both locally as well as abroad,
- Asking for correction in the event your personal data are processed as incomplete or incorrect and requesting any operation made to this effect to be advised to such third parties whom your personal data are transferred to,
- Despite having being processed in accordance with the provisions of Law Number 6698 About Protection Of Personal Data and such other relevant laws, in the event those reasons necessitating processing of the same, asking for deleting or elimination of your personal data and requesting any operation made to this effect to be advised to such third parties whom your personal data are transferred to,

- Objecting to generation of any result against your side by means of analysis of the processed data exclusively via automated systems,
- In the event of your suffering any damage on grounds of illegal processing of personal data, asking for recovery of such damage.

You are free to forward your claims regarding these rights over the support section included in our Web Site. Your application shall be responded free of charge. However, in the event the procedure requested requires any further cost, fees under such tariff specified by Personal Data Protection Board shall be claimed from the applicant.
